**Malema and EFF; not an example of democracy - CDP**

“For a so-called leader and ‘Commander-in Chief’ Malema, of a so-called political party, the EFF, to defy the law and confront the police by challenging them to kill him and his supporters, as he encourages lawless mobs to pillage and burn, in the townships, is tantamount to treason.” Says Rev Theunis Botha, Leader of the Christian Democratic Party, (CDP).
